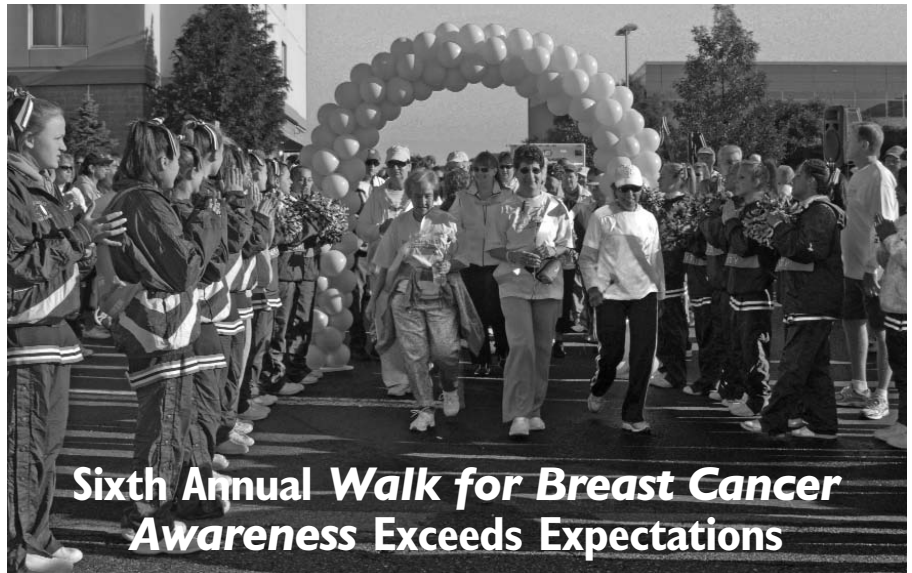

### Sixth Annual Walk for Breast Cancer Awareness Exceeds Expectations

With a crisp chill in the air as harbinger of the pending autumn season, more than 400 walkers joined presenting sponsors, **Commerce Bank, sanofi aventis, WMTR-WDHA, Atlantic Neuro-Surgical Specialists and The Donald and Evelyn Spiro Foundation**, along with Saint Clare's Health System for the Sixth Annual *Walk for Breast Cancer Awareness*. This year's walk, once again hosted by the Rockaway Townsquare Mall, Simon Property Group and the Hilton Garden Inn, raised more than \$105,000 in support of *The Women's Health Center* at Saint Clare's Hospital/Dover. This year's walk exceeded fundraising goals and set yet another record for this annual event.

Following months of hard work and planning by an organizing committee of community leaders, the 5K walk stepped off from the Hilton Garden Inn for two circuits of the mall's ring road. Many of the record

number of walkers, ranging from Saint Clare's employees to corporate teams to members of the community, walked in honor or memory of those who have fought the fight against breast cancer. A core group of cancer survivors and their caregivers led this year's walk.

Prior to the Walk, a special survivor recognition ceremony was held to honor and memorialize those who have fought the disease. Caregivers for these breast cancer patients were

## Saint Clare's Ranks High in 2007 Hospital Performance Report

The acute care hospitals of Saint Clare's Health System, took the top four spots statewide for the treatment of heart attack, pneumonia, heart failure and surgical infection prevention in New Jersey's fourth annual *Hospital Performance Report*, released September 6 by the New Jersey Department of Health and Senior Services. Within Morris County, Saint Clare's Hospitals in Denville and Dover ranked highest among Morris County hospitals for all conditions tracked.

"We are proud of the work done by our physicians, nurses and the entire staff throughout Saint Clare's Health System," said **Gary J. Blan**, FACHE, President and Chief Executive Officer. "For our three acute care hospital campuses to hold such high rankings, both within the county and across the state, is a tribute to the teamwork of our medical staff and clinical support staff at all our acute care facilities, supported by the Saint Clare's family. The state report is validation of our ongoing commitment to provide high quality healthcare for the people of northwest New Jersey."

For heart attack treatment, Saint Clare's Hospital in Dover achieved a score of 99 percent (2nd place

statewide) and Denville and Sussex achieved a score of 98 percent (3rd place statewide). For treatment of patients with pneumonia, Denville ranked second in the state with a score of 97 percent, Dover ranked third with 96 percent, and Sussex ranked fourth with 95 percent. Rankings for treatment of heart failure included Sussex and Dover at 98 percent (3rd place statewide) and 97 percent for Denville (4th place statewide). Lastly, for prevention of surgical infections, Denville (98 percent), Sussex (97 percent) and Dover (96 percent), ranked second, third and fourth respectively in the state.

The *Hospital Performance Report*, prepared from data by the New Jersey Department of Health and Senior Services (NJDOHSS), ranks New Jersey hospitals on how well each performs in adhering to industry standards in treating pneumonia, heart attacks, and heart failure. For the first time in 2007, scores and rankings for the prevention of surgical infection have been added. The NJDOHSS notes that since the first report in 2004, scores for the treatment of pneumonia and myocardial infarction (heart attacks) statewide have improved significantly.

## Saint Clare's Hospital Dover Wins National Satisfaction Award

## Saint Clare's Designated as Primary Stroke Center

**B**ecause minutes could mean the difference between recovery and permanent disability — even death — for stroke victims, Saint Clare's Health System offers new hope to the community with its recent designation as a Primary Stroke Center by The Joint Commission. The Stroke Centers, located at Saint Clare's Hospitals in Denville and Dover, provide advanced medical teams that quickly diagnose strokes and transient ischemic attacks (TIAs) and promptly begin treatment, increasing the chances of recovery and reducing chances of permanent disability.

The Joint Commission's Primary Stroke Center Certification is based on the recommendations for primary stroke centers published by the Brain Attack Coalition and the American Stroke Association's statements/guidelines for stroke care. Saint Clare's has demonstrated that its stroke care program follows national standards and guidelines that can significantly improve outcomes for stroke patients.

"Stroke is the third leading cause of death in America and the #1 leading cause of adult disability. Nationally,

there are approximately 750,000 strokes yearly and 160,000 of those affected will die," said **Jane Smith, RN**, Stroke Program Coordinator. "Though methods of treatment have improved and Americans are generally more vigilant with regards to their health, there is still a need for education, awareness, and access to advanced medical care for those who suffer a stroke.



Our community can now obtain the highest levels of stroke care quickly and easily, raising their chances of a full recovery."

Stroke is a type of cardiovascular disease, affecting the arteries leading to and within the brain. A stroke occurs when a blood vessel carrying oxygen and nutrients to the brain is either blocked by a clot or bursts. When this occurs, part of the brain cannot get the blood and oxygen it needs, and it begins to die. Primary symptoms of stroke include numbness of the face, arm or leg; confusion or dizziness; problems with balance, vision or speech; and a sudden severe headache. Strokes can cause paralysis, affect speech, vision and memory, and cause other problems.

"The most important part of the

treatment of any stroke is prompt and effective intervention. Time lost is brain lost," says **Paul Roberts, M.D.**, Medical Director of Saint Clare's Primary Stroke Centers. "Often patients disregard common stroke symptoms as that of less serious conditions and illnesses. A delay in seeking medical help could mean serious, long-term disability or even death."

Staffed by a team of specialized doctors, nurses and technologists, Saint Clare's Hospital is ready to evaluate and treat strokes 24 hours a day, seven days a week. To provide prompt diagnosis, treatment and intervention for stroke patients, the Stroke Team is comprised of Emergency Department physicians and nurses that examine the patient on arrival and order specific diagnostic tests. Once the tests are completed, the Saint Clare's stroke team will develop a plan and promptly begin treatment.

Saint Clare's has designated specific inpatient beds, at both locations, for stroke patients and has specially trained nurses and dedicated staff to provide this unique, focused care. The Stroke Centers will work in cooperation with Saint Clare's rehabilitation centers and others in the area to ensure a continuum of care and therapy that may be required.

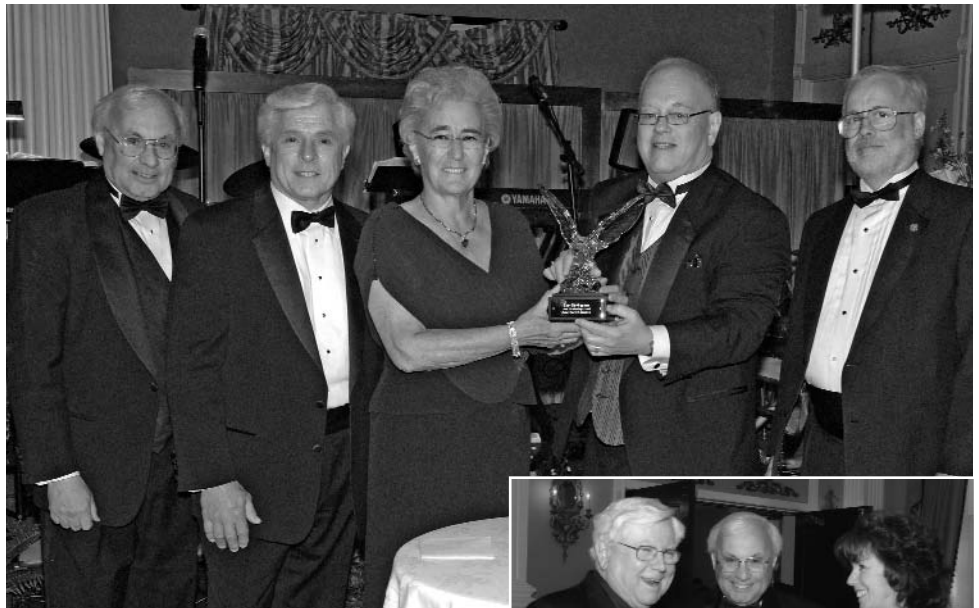

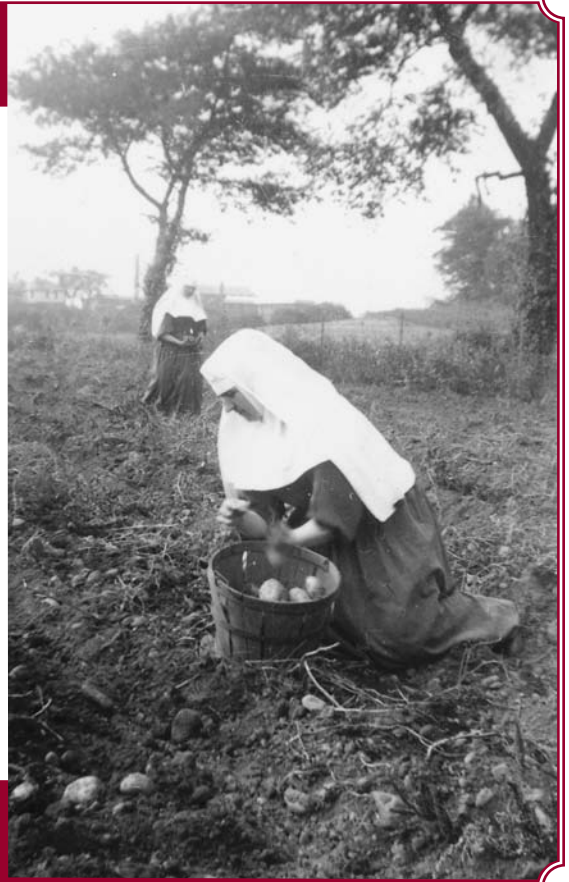
